Studies performed in animal models other than rats did not show any association between carbon black and lung tumors. Moreover, a two-year cancer bioassay using a typical toner preparation containing carbon black demonstrated no association between toner exposure and tumor development in rats. Other ingredients of this product have not been classified as carcinogens according to IARC monographs, NTP and OSHA.
